



# Canberra Blind Society Inc Minutes of the Annual General Meeting held in Room 9, Griffin Centre, Genge Street Canberra at 6pm Thursday, November 17, 2022

#### Welcome

President Heather Fitzpatrick opened the meeting at 6.10pm and welcomed all in attendance and online.

#### Minutes

Moved Peter Granleese, seconded Deb Quinnell: That the minutes of the Annual General Meting of November 18, 2021, be accepted as a correct record of that meeting. Carried.

# President's Report

Heather Fitzpatrick read her report, of which a copy is filed with the minutes.

She reflected on the impact of COVID-19, noting some groups had continued to meet online as had the CBS board. The CBS Newsletter had continued to be produced and visits to the Australian National Botanic Gardens and Christmas lunch had been possible. A weekend camp at Birrigai had been held in March.

Eyes for Life Canberra had been further developed with contacts with professions such as optometrists. The Canberra Blind Society and Eyes for Life Canberra had participated in two expos and a dinner had been held to thank Peter Granleese and Scott Grimley for their years of service to CBS.

Donations of more than \$15,000 had been received. The role of volunteers had continued to be crucial. Heather Fitzpatrick noted the value of staff and she thanked members of the board for their service.

### Treasurer's Report

Treasurer Dianne White resigned from the board in September. Subsequently, Heather Fitzpatrick had filled the position. She tabled the Treasurer's Report and the Auditor's Report.

Copies of both reports are filed with the minutes.

# **Executive Officer's Report**

A copy of the report is filed with the minutes.

Glenn Doney noted an ACT government grant had provided for new furniture and improvements to kitchen cookware. Other purchases had included a new Braille embosser, updated JAWS software and large computer screens.

Glenn Doney outlined successful grant applications and the range of activities these grants had made possible. He thanked staff, volunteers and the board for their support, encouragement and continued commitment to people with vision impairment.

#### **Election of Office Bearers**

Lindy Hou was the only nomination for the vacant treasurer's position and was duly elected.

There were no nominations for the vacant vice-president's position which remains vacant.

Chris MacDonald, Sharon Sobey and Trevor Watkin were nominated for the three vacant board positions. There being no other nominations, they were duly elected.

#### Confirmation of Public Officer

Peter Granleese was willing to continue as public officer and was duly confirmed.

### Appointment of Auditor

Scott Ellis, of Les Ellis and Associates was reappointed as CBS auditor.

### Appointment of Patrons

Margaret Reid and Roy Daniell were reappointed as CBS patrons.

### **Constitution Amendment**

Moved Robert Altimore, seconded Heather Fitzpatrick: That the meeting endorse the decision of the CBS General Meeting of July 22, 2021, to amend the objectives of the CBS Constitution to comply with the requirements of a public benevolent institution as required by the Australian Charities and Not-For-Profits Commission. Carried.

### Presentation

Claire Manning presented a book, Moments We See, which she created as an art project. The book has images with printed and Braille descriptions. Heather Fitzpatrick encouraged people to look at the book in the CBS office.
